

Roads (Works, Use and Compensation) Ordinance (Chapter 370)

Scheme annexed to Plan No. TKSR/GZP/101 under section 5 describing

Retrofitting of Noise Barriers on Tam Kon Shan Road, Tsing Yi

General Description of the Works

Under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (“the Ordinance”), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. TKSR/GZP/101 (“the Plan”) annexed hereto and described hereunder. The proposed works are required to mitigate traffic noise along the section of Tam Kon Shan Road fronting Cheung Fat Estate and Cheung On Estate.

2. The general nature of the proposed works is as follows:–
 - (i) installation of cantilever noise barriers at the sections of Tam Kon Shan Road fronting Chun Fat House and On Tao House;
 - (ii) installation of a full enclosure at the section of Tam Kon Shan Road between On Tao House and On Yun House;
 - (iii) permanent closure of sections of the existing footpath and an amenity area;
 - (iv) temporary closure of sections of the existing carriageway, footpaths and amenity areas; and reinstatement works after completion of works; and
 - (v) ancillary works including civil, geotechnical, drainage, utilities, street lighting and landscaping works, as well as installation of traffic aids.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Logistics proposes that powers under section 17 of the Ordinance may be exercised to close permanently sections of the existing footpath and an amenity area; and temporarily sections of the existing carriageways, footpaths and amenity areas within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths and amenity areas are to be closed, will be issued under section 18 of the Ordinance as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Logistics proposes that powers under section 20 of the Ordinance may be exercised to require alteration of the course or position of any gas, electricity, water or telecommunications service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, gas pipes, drainage pipes and any other apparatus lying within the limit of works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Ordinance as and when required.
