

**RAILWAYS ORDINANCE (Chapter 519)

**KWUN TONG LINE EXTENSION**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF WUHU STREET TEMPORARY PLAYGROUND,  
PART OF YAN FUNG STREET REST GARDEN,  
A FOOTPATH NEAR YAN FUNG STREET REST GARDEN AND  
THE STAIRCASES OF A FOOTBRIDGE ACROSS CHATHAM ROAD NORTH**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 28 April 2016 (the ‘Order’), authorized:–

- (I) the temporary closure of Wuhu Street Temporary Playground, as delineated and shown in pink on the Plan numbered KTE/G03/0006/5 during the period from 23 May to 30 June 2016; and
- (II) (a) the temporary closure of part of Yan Fung Street Rest Garden, as delineated and shown in orange on the Plan numbered KTE/G03/0006/5;  
  
(b) the temporary partial closure of the footpath near Yan Fung Street Rest Garden, as delineated and shown in red on the Plan numbered KTE/G03/0006/5; and  
  
(c) the temporary partial closure of the staircases of the footbridge across Chatham Road North, as delineated and shown in blue on the Plan numbered KTE/G03/0006/5,

during the period from 23 May to 30 September 2016,

for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the areas of Wuhu Street Temporary Playground and Yan Fung Street Rest Garden, the footpath and the staircases to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near Wuhu Street Temporary Playground, Yan Fung Street Rest Garden, the footpath and the staircases affected by the Order on 6 May 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Wuhu Street Temporary Playground, Yan Fung Street Rest Garden, the footpath and the staircases or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Wuhu Street Temporary Playground, Yan Fung Street Rest Garden, the footpath and the staircases affected by the Order.

Notice is hereby given that further closure of the same part or parts of Wuhu Street Temporary Playground, Yan Fung Street Rest Garden, the footpath and the staircases or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) Wuhu Street Temporary Playground, as delineated and shown in pink on the Plan numbered KTE/G03/0006/5.	Wuhu Street Temporary Playground will be temporarily closed to facilitate the construction of the footbridge across Chatham Road North, the associated railway facilities of the Kwun Tong Line Extension and the reinstatement works.
(b) Part of Yan Fung Street Rest Garden, as delineated and shown in orange on the Plan numbered KTE/G03/0006/5.	Part of Yan Fung Street Rest Garden will be temporarily closed to facilitate the construction of the footbridge across Chatham Road North and the associated railway facilities of the Kwun Tong Line Extension.
(c) The footpath near Yan Fung Street Rest Garden, as delineated and shown in red on the Plan numbered KTE/G03/0006/5.	Parts of the footpath widths will be temporarily closed to facilitate the construction of the footbridge across Chatham Road North, the associated railway facilities of the Kwun Tong Line Extension and the reinstatement works.
(d) The staircases of the footbridge across Chatham Road North, as delineated and shown in blue on the Plan numbered KTE/G03/0006/5.	Parts of the staircases will be temporarily closed to facilitate modification works of the staircases and the reinstatement works.
