Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 12 May 2014 (the 'Order'), authorized:—

- the temporary closure of the open space in Fat Kwong Street Playground, as delineated and shown in red on the Plan numbered KTE/G03/0002/2;
- (II) the temporary closure of Yan Fung Street, as delineated and shown in light blue on the Plan numbered KTE/G03/0002/2;
- (III) the temporary partial closure of the section of Wylie Road between its junction with Gascoigne Road and a point about 240 metres northwest of the junction, and the section of Wylie Path between its junction with Wylie Road and a point about 45 metres northeast of the junction, as delineated and shown in pink and light blue respectively on the Plan numbered KTE/G02/0002/2;
- (IV) the temporary partial closure of the section of Chung Hau Street between its junction with Fat Kwong Street and a point about 120 metres southeast of its junction with Hau Man Street, the section of Fat Kwong Street between a point about 150 metres northwest of its junction with Shun Yung Street and a point about 70 metres southeast of the junction, and the section of Shun Yung Street between its junction with Fat Kwong Street and a point about 55 metres northeast of the junction, as delineated and shown in pink, light green and orange respectively on the Plan numbered KTE/G03/0002/2;
- (V) the temporary partial closure of the section of the slip road from Winslow Street to Chatham Road North, and the section of the slip road from Hong Chong Road to Chatham Road North, as delineated and shown in brown and grey respectively on the Plan numbered KTE/G03/0002/2;

- (VI) the temporary partial closure of Walker Road, the section of Ping Chi Street around Fat Kwong Street Playground, the section of Station Lane between Wuhu Street Temporary Playground and Walker Road, and the section of Chatham Road North between its junctions with Bulkeley Street and Valley Road, as delineated and shown in dark blue, light purple, beige and yellow respectively on the Plan numbered KTE/G03/0002/2;
- (VII) the temporary partial closure of Wuhu Street, as delineated and shown in dark green on the Plans numbered KTE/G03/0002/2 and KTE/G04/0002/3; and
- (VIII) the temporary partial closure of the footpath between Wuhu Street and Station Lane, and the footpath between Walker Road and Wuhu Street Temporary Playground, as delineated and shown in dark purple on the Plan numbered KTE/G03/0002/2.

during the period from 27 May to 25 September 2014 for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the open space, the sections of the roads and the footpaths to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open space, the roads and the footpaths or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space, the roads and the footpaths affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open space, the roads and the footpaths or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) The open space in Fat Kwong Street Playground, as delineated and shown in red on the Plan numbered KTE/G03/0002/2. The open space will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Kwun Tong Line Extension.

- (b) Yan Fung Street, as delineated and shown in light blue on the Plan numbered KTE/G03/0002/2.
- The carriageways and footpaths will be temporarily closed to facilitate the construction of the railway station at Ho Man Tin and the associated railway facilities of the Kwun Tong Line Extension.
- (c) The section of Wylie Road between its junction with Gascoigne Road and a point about 240 metres northwest of the junction, and the section of Wylie Path between its junction with Wylie Road and a point about 45 metres northeast of the junction, as delineated and shown in pink and light blue respectively on the Plan numbered KTE/G02/0002/2.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the plant building and the associated railway facilities of the Kwun Tong Line Extension.

(d) The section of Chung Hau Street between its junction with Fat Kwong Street and a point about 120 metres southeast of its junction with Hau Man Street, the section of Fat Kwong Street between a point about 150 metres northwest of its junction with Shun Yung Street and a point about 70 metres southeast of the junction, and the section of Shun Yung Street between its junction with Fat Kwong Street and a point about 55 metres the iunction. northeast of delineated and shown in pink, light green and orange respectively on the Plan numbered KTE/G03/0002/2.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station at Ho Man Tin, the railway tunnel, the associated railway facilities, and a footbridge and its associated structures of the Kwun Tong Line Extension.

(e) The section of the slip road from Winslow Street to Chatham Road North, and the section of the slip road from Hong Chong Road to Chatham Road North, as delineated and shown in brown and grey respectively on the Plan numbered KTE/G03/0002/2. Parts of the carriageway widths will be temporarily closed to facilitate the construction of the railway station at Ho Man Tin, the railway tunnel and the associated railway facilities of the Kwun Tong Line Extension.

(f) Walker Road, the section of Ping Chi Street around Fat Kwong Street Playground, the section of Station Lane between Wuhu Street Temporary Playground and Walker Road, as delineated and shown in dark blue, light purple and beige respectively on the Plan numbered KTE/G03/0002/2. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, the associated railway facilities, and a footbridge and its associated structures of the Kwun Tong Line Extension.

(g) The section of Chatham Road North between its junctions with Bulkeley Street and Valley Road, as delineated and shown in yellow on the Plan numbered KTE/G03/0002/2. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station at Ho Man Tin, the associated railway facilities, and a footbridge and its associated structures of the Kwun Tong Line Extension.

(h) Wuhu Street, as delineated and shown in dark green on the Plans numbered KTE/G03/0002/2 and KTE/G04/0002/3. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, the associated railway facilities, and a footbridge and its associated structures of the Kwun Tong Line Extension.

The open space, the roads and the footpaths to be affected

(i) The footpath between Wuhu Street and Station Lane, and the footpath between Walker Road and Wuhu Street Temporary Playground, as delineated and shown in dark purple on the Plan numbered KTE/G03/0002/2. Parts of the footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities and a footbridge and its associated structures of the Kwun Tong Line Extension.
