KWUN TONG LINE EXTENSION

NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF  
MAN SIU STREET AND SECTIONS OF HUNG HOM ROAD,  
TAK MAN STREET, MAN TAI STREET AND  
WAN HOI STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 May 2011 (the ‘Order’), authorized the temporary closure of Man Siu Street, and the temporary partial closure of sections of Hung Hom Road between Tak Hong Street and Tak Fung Street, sections of Tak Man Street between its junction with Hung Hom Road and a point about 170 metres northwest of the junction, sections of Man Tai Street at its junction with Man Siu Street, and sections of Wan Hoi Street between its junction with Tak On Street and a point about 50 metres north of the junction during the period from 27 May 2011 to 26 May 2012 for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out and the sections of the roads to be affected and the manner in which they will be affected are given in the Schedule below.

A copy of the Order and the Plan numbered KTE/G04/0001/1 (the ‘Plan’) delineating and showing the sections of the roads affected in green, blue, purple, red and yellow respectively may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 20 May 2011.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or

restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

#### SCHEDULE

<i>The roads to be affected</i>	<i>Description of the works and the manner in which the roads will be affected</i>
(a) Man Siu Street, as delineated and shown in green on the Plan numbered KTE/G04/0001/1.	The carriageways and parts of the footpath widths will be temporarily closed for the modification of the existing footbridge and the staircase, the construction of the emergency accesses, ventilation shaft, temporary construction shaft, station entrance of the railway station at Whampoa and the associated railway facilities of the Kwun Tong Line Extension.
(b) Sections of Hung Hom Road between Tak Hong Street and Tak Fung Street, sections of Tak Man Street between its junction with Hung Hom Road and a point about 170 metres northwest of the junction, and sections of Man Tai Street at its junction with Man Siu Street, as delineated and shown in blue, purple and red respectively on the Plan numbered KTE/G04/0001/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway station at Whampoa, railway tunnel and the associated railway facilities of the Kwun Tong Line Extension.
(c) Sections of Wan Hoi Street between its junction with Tak On Street and a point about 50 metres north of the junction, as delineated and shown in yellow on the Plan numbered KTE/G04/0001/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of emergency access and emergency escape access, ventilation shaft, temporary construction shaft, railway tunnel and railway station at Whampoa, and the associated railway facilities of the Kwun Tong Line Extension.
