**KWUN TONG LINE EXTENSION**

**NOTICE OF ORDER AUTHORIZING  
 TEMPORARY CLOSURE OF SECTIONS OF  
 MAN SIU STREET, MAN TAI STREET, HUNG HOM ROAD,  
 TAK MAN STREET AND WUHU STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 8 June 2017 (the 'Order'), authorized the temporary partial closure of sections of Man Siu Street, the section of Man Tai Street at its junction with Man Siu Street, the section of Hung Hom Road between Tak Hong Street and Tak Fung Street, the section of Tak Man Street between Hung Hom Road and Wuhu Street, and the section of Wuhu Street between Tak Man Street and Taku Street, as delineated and shown in dark blue, yellow, brown, grey and dark green respectively on the Plan numbered KTE/G04/0004/9 during the period from 1 July to 31 December 2017 for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the roads affected by the Order on 16 June 2017.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) Sections of Man Siu Street, as delineated and shown in dark blue on the Plan numbered KTE/G04/0004/9.	Parts of the footpath widths will be temporarily closed to facilitate the reinstatement works.
(b) The section of Man Tai Street at its junction with Man Siu Street, the section of Hung Hom Road between Tak Hong Street and Tak Fung Street, the section of Tak Man Street between Hung Hom Road and Wuhu Street, and the section of Wuhu Street between Tak Man Street and Taku Street, as delineated and shown in yellow, brown, grey and dark green respectively on the Plan numbered KTE/G04/0004/9.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the reinstatement works.
