THIS DRAWING IS PREPARED BASED ON DRAWING NO. KTE-G01 (REVISION 1) AND IS INTENDED TO SHOW THE TEMPORARY CLOSURE OF PART OF GASCOIGNE ROAD/NATHAN ROAD REST GARDEN (STAGE 1) (HIGHLIGHTED IN BLUE), AND THE TEMPORARY PARTIAL CLOSURE OF SECTIONS OF NATHAN ROAD AND GASCOIGNE ROAD (HIGHLIGHTED IN YELLOW AND PINK RESPECTIVELY).
