KWUN TONG LINE EXTENSION

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF
GASCOIGNE ROAD/NATHAN ROAD REST GARDEN (STAGE I), AND
SECTIONS OF NATHAN ROAD AND GASCOIGNE ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 9 June 2015 (the 'Order'), authorized:—

- (I) the temporary closure of part of Gascoigne Road/Nathan Road Rest Garden (Stage I), as delineated and shown in blue on the Plan numbered KTE/G01/0003/4; and
- (II) the temporary partial closure of the section of Nathan Road adjacent to Gascoigne Road/Nathan Road Rest Garden (Stage I), and the section of Gascoigne Road between a point about 50 metres southeast of its junction with Nathan Road (near Methodist College) and a point about 170 metres southeast of the junction, as delineated and shown in yellow and pink respectively on the Plan numbered KTE/G01/0003/4,

during the period from 4 July 2015 to 31 March 2016 for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the part of Gascoigne Road/Nathan Road Rest Garden (Stage I) and the sections of roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered KTE/G01/0003/4 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near Gascoigne Road/Nathan Road Rest Garden (Stage I) and the roads affected by the Order on 19 June 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Gascoigne Road/Nathan Road Rest Garden (Stage I) and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Gascoigne Road/Nathan Road Rest Garden (Stage I) and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of Gascoigne Road/Nathan Road Rest Garden (Stage I) and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

- (b) The section of Nathan Road adjacent to Gascoigne Road/Nathan Road Rest Garden (Stage I), as delineated and shown in yellow on the Plan numbered KTE/G01/0003/4. Parts of the footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Kwun Tong Line Extension, and for the modification of the existing cable tunnel of the MTR Kwun Tong Line.
- (c) The section of Gascoigne Road between a point about 50 metres southeast of its junction with Nathan Road (near Methodist College) and a point about 170 metres southeast of the junction, as delineated and shown in pink on the Plan numbered KTE/G01/0003/4. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Kwun Tong Line Extension.

Statement on Personal Data
