KWUN TONG LINE EXTENSION

**NOTICE OF ORDER AUTHORIZING
PERMANENT CLOSURE OF SECTIONS OF WUHU STREET,
CHUNG YEE STREET AND SHEUNG LOK STREET;
PARTS OF WUHU STREET TEMPORARY PLAYGROUND, AND
A SECTION OF THE FOOTPATH CONNECTING
FAT KWONG STREET AND CHUNG YEE STREET; AND
TEMPORARY CLOSURE OF A SECTION OF WUHU STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 7 September 2016 (the 'Order'), authorized:-

- (I) (a) the permanent closure of part of the footpath widths of the section of Wuhu Street at a point about 18 metres southeast of its junction with Chatham Road North, and part of the footpath widths of the section of Wuhu Street adjacent to Wuhu Street Temporary Playground, as delineated and shown in red on the Plan numbered KTE/G03/0009/1; and
- (b) the permanent closure of part of the carriageway widths of the section of Wuhu Street at a point about 10 metres east of its junction with Chatham Road North, as delineated and shown in orange on the Plan numbered KTE/G03/0009/1,

with effect from 26 September 2016;

- (II) (a) the permanent closure of parts of Wuhu Street Temporary Playground, as delineated and shown in dark green on the Plan numbered KTE/G03/0009/1;
- (b) the permanent closure of part of the footpath widths of the section of Chung Yee Street near its junction with Hau Man Street, parts of the footpath widths of sections of Chung Yee Street at the points about 10 metres, 22 metres, 32 metres, 42 metres, 50 metres, 58 metres, 70 metres, 82 metres, 92 metres and 100 metres east of its junction with Hau Man Street, and part of the footpath widths of the section of Chung Yee Street between a point about 105 metres east of its junction with Hau Man Street and a point about 130 metres east of the junction, as delineated and shown in red on the Plan numbered KTE/G07/0009/1;

- (c) the permanent closure of parts of the footpath widths of sections of Sheung Lok Street at the points about 77 metres, 85 metres and 100 metres northeast of its junction with Fat Kwong Street, part of the footpath widths of the section of Sheung Lok Street between a point about 106 metres northeast of its junction with Fat Kwong Street and a point about 109 metres northeast of the junction, and part of the footpath widths of the section of Sheung Lok Street between a point about 120 metres northeast of its junction with Fat Kwong Street and a point about 125 metres northeast of the junction, as delineated and shown in dark green on the Plan numbered KTE/G07/0009/1; and
- (d) the permanent closure of the section of the footpath connecting Fat Kwong Street and Chung Yee Street between a point about 5 metres southwest of its junction with Fat Kwong Street and a point about 40 metres southwest of the junction, as delineated and shown in orange on the Plan numbered KTE/G07/0009/1,

with effect from 1 October 2016; and

- (III) the temporary partial closure of the section of Wuhu Street between its junctions with Tak Man Street and Taku Street, as delineated and shown in dark green on the Plan numbered KTE/G04/0009/1 during the period from 26 September to 31 December 2016,

for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the sections of the roads and footpath and the areas of Wuhu Street Temporary Playground to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered KTE/G03/0009/1, KTE/G04/0009/1 and KTE/G07/0009/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads, Wuhu Street Temporary Playground and the footpath affected by the Order on 15 September 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads, Wuhu Street Temporary Playground and the footpath or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads, Wuhu Street Temporary Playground and the footpath affected by the Order.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

- (f) The section of the footpath connecting Fat Kwong Street and Chung Yee Street between a point about 5 metres southwest of its junction with Fat Kwong Street and a point about 40 metres southwest of the junction, as delineated and shown in orange on the Plan numbered KTE/G07/0009/1. The footpath widths will be permanently closed for the provision of the covered walkway, the footbridge and the associated structures of the Kwun Tong Line Extension.
- (g) The section of Wuhu Street between its junctions with Tak Man Street and Taku Street, as delineated and shown in dark green on the Plan numbered KTE/G04/0009/1. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Kwun Tong Line Extension.
