**KWUN TONG LINE EXTENSION**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF  
PART OF A FOOTBRIDGE ACROSS CHATHAM ROAD NORTH,  
THE OPEN SPACE IN WUHU STREET TEMPORARY PLAYGROUND,  
PART OF THE OPEN SPACE IN YAN FUNG STREET REST GARDEN,  
A FOOTPATH NEAR YAN FUNG STREET REST GARDEN AND  
THE STAIRCASES OF A FOOTBRIDGE ACROSS CHATHAM ROAD NORTH**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 September 2014 (the 'Order'), authorized:-

- (I) the temporary partial closure of part of the footbridge across Chatham Road North, as delineated and shown in yellow on the Plan numbered KTE/G03/0006/3, during the period from 26 September 2014 to 1 January 2015; and
- (II)
  - (a) the temporary closure of the open space in Wuhu Street Temporary Playground, as delineated and shown in pink on the Plan numbered KTE/G03/0006/3;
  - (b) the temporary closure of part of the open space in Yan Fung Street Rest Garden, as delineated and shown in orange on the Plan numbered KTE/G03/0006/3;
  - (c) the temporary partial closure of the footpath near Yan Fung Street Rest Garden, as delineated and shown in red on the Plan numbered KTE/G03/0006/3; and
  - (d) the temporary partial closure of the staircases of the footbridge across Chatham Road North, as delineated and shown in blue on the Plan numbered KTE/G03/0006/3,

during the period from 26 September 2014 to 22 May 2015,

for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the part of the footbridge, the open spaces, the footpath and the staircases to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the footbridge, the open spaces, the footpath and the staircases affected by the Order on 19 September 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge, the open spaces, the footpath and the staircases or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge, the open spaces, the footpath and the staircases affected by the Order.

Notice is hereby given that further closure of the same part or parts of the footbridge, the open spaces, the footpath and the staircases or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
