# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF A STAIRCASE NEAR THE JUNCTION OF FAT KWONG STREET AND CHUNG HAU STREET; A SECTION OF THE ACCESS ROAD BETWEEN CHUNG HAU STREET AND KING'S PARK HIGH LEVEL SERVICE RESERVOIR PLAYGROUND; A FOOTPATH CONNECTING FAT KWONG STREET AND CHUNG YEE STREET; A FOOTPATH AND STAIRCASE CONNECTING FAT KWONG STREET AND HO MAN TIN EAST SERVICE RESERVOIR PLAYGROUND; CHUNG YEE STREET; AND SECTIONS OF CHUNG HAU STREET, HAU MAN STREET, FAT KWONG STREET AND SHEUNG LOK STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Acting Deputy Secretary for Transport and Housing (Transport) has, by order made on 29 August 2013 (the 'Order'), authorized:-

- (I) the temporary closure of the staircase near the junction of Fat Kwong Street and Chung Hau Street, as delineated and shown in purple on the Plans numbered KTE/G03/0005/2 and KTE/G07/0005/2;
- (II) the temporary partial closure of the section of the access road between Chung Hau Street and King's Park High Level Service Reservoir Playground, as delineated and shown in light blue on the Plan numbered KTE/G03/0005/2;
- (III) the temporary partial closure of the footpath connecting Fat Kwong Street and Chung Yee Street, as delineated and shown in pink on the Plans numbered KTE/G03/0005/2 and KTE/G07/0005/2;
- (IV) the temporary partial closure of the footpath and staircase connecting Fat Kwong Street and Ho Man Tin East Service Reservoir Playground, as delineated and shown in brown on the Plan numbered KTE/G07/0005/2;
- (V) the temporary partial closure of Chung Yee Street, as delineated and shown in orange on the Plans numbered KTE/G02/0005/2, KTE/G03/0005/2 and KTE/G07/0005/2;
- (VI) the temporary partial closure of the section of Chung Hau Street near its junction with Hau Man Street, and the section of Hau Man Street between its junction with Chung Hau Street and a point about 15 metres north of its junction with Chung Yee Street, as delineated and shown in red and green respectively on the Plans numbered KTE/G02/0005/2, KTE/G03/0005/2 and KTE/G07/0005/2; and

(VII) the temporary partial closure of the section of Fat Kwong Street between a point about 30 metres north of its junction with Sheung Lok Street and a point about 110 metres south of the junction, and the section of Sheung Lok Street between its junction with Fat Kwong Street and a point about 220 metres east of the junction, as delineated and shown in yellow and dark blue respectively on the Plan numbered KTE/G07/0005/2,

during the period from 30 September 2013 to 29 September 2014 for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out and the staircases, the footpaths and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the staircases, the footpaths and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the staircases, the footpaths and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the staircases, the footpaths and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
