NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF A STAIRCASE NEAR THE JUNCTION OF
FAT KWONG STREET AND CHUNG HAU STREET;
A SECTION OF THE ACCESS ROAD BETWEEN CHUNG HAU STREET AND
KING'S PARK HIGH LEVEL SERVICE RESERVOIR PLAYGROUND;
A FOOTPATH CONNECTING FAT KWONG STREET AND CHUNG YEE STREET;
A FOOTPATH AND STAIRCASE CONNECTING FAT KWONG STREET AND
HO MAN TIN EAST SERVICE RESERVOIR PLAYGROUND; CHUNG YEE STREET;
AND SECTIONS OF CHUNG HAU STREET, HAU MAN STREET,
FAT KWONG STREET AND SHEUNG LOK STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 12 September 2011 (the 'Order'), authorized:—

- (I) the temporary closure of a staircase near the junction of Fat Kwong Street and Chung Hau Street, as delineated and shown in purple on Plans numbered KTE/G03/0005/1 and KTE/G07/0005/1;
- (II) the temporary partial closure of a section of the access road between Chung Hau Street and King's Park High Level Service Reservoir Playground, as delineated and shown in light blue on Plan numbered KTE/G03/0005/1;
- (III) the temporary partial closure of a footpath connecting Fat Kwong Street and Chung Yee Street, as delineated and shown in pink on Plans numbered KTE/G03/0005/1 and KTE/G07/0005/1;
- (IV) the temporary partial closure of a footpath and staircase connecting Fat Kwong Street and Ho Man Tin East Service Reservoir Playground, as delineated and shown in brown on Plan numbered KTE/G07/0005/1;
- (V) the temporary partial closure of sections of Chung Yee Street, as delineated and shown in orange on Plans numbered KTE/G02/0005/1, KTE/G03/0005/1 and KTE/G07/0005/1;
- (VI) the temporary partial closure of sections of Chung Hau Street near its junction with Hau Man Street; and sections of Hau Man Street between its junction with Chung Hau Street and a point about 15 metres north of its junction with Chung Yee Street, as delineated and shown in red and green respectively on Plans numbered KTE/G02/0005/1, KTE/G03/0005/1 and KTE/G07/0005/1; and
- (VII) the temporary partial closure of sections of Fat Kwong Street between a point about 30 metres north of its junction with Sheung Lok Street and a point about 110 metres south of the junction; and sections of Sheung Lok Street between its junction with Fat Kwong Street and a point about 220 metres east of the junction, as delineated and shown in yellow and dark blue respectively on Plan numbered KTE/G07/0005/1,

during the period from 30 September 2011 to 29 September 2012 for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out and the footpaths, the staircases and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered KTE/G02/0005/1, KTE/G03/0005/1 and KTE/G07/0005/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the footpaths, the staircases and the roads affected by the Order on 16 September 2011.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the footpaths, the staircases and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footpaths, the staircases and the roads affected by the Order. Such a written claim should reach the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong on or before 31 December 2011; or the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Admiralty, Hong Kong on or after 1 January 2012.

Notice is hereby given that further closure of the same part or parts of the footpaths, the staircases and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

Parts of the carriageway widths will be temporarily closed in connection with the construction of the footbridge and the associated structures of the Kwun Tong Line Extension.
