

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

KWUN TONG LINE EXTENSION

**NOTICE OF ORDER AUTHORIZING
PERMANENT CLOSURE OF
AN EXISTING FOOTBRIDGE ACROSS CHATHAM ROAD NORTH; AND
TEMPORARY CLOSURE OF PART OF A NEW FOOTBRIDGE ACROSS
CHATHAM ROAD NORTH AND A SECTION OF CHATHAM ROAD NORTH**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 December 2014 (the 'Order'), authorized:—

- (I) the permanent closure of the existing footbridge across Chatham Road North, as delineated and shown in green on the Plan numbered KTE/G03/0007/1 with effect from 2 January 2015;
- (II) the temporary closure of part of the new footbridge across Chatham Road North, as delineated and shown in red on the Plan numbered KTE/G03/0007/1 during the period from 2 January to 25 September 2015; and
- (III) the temporary closure of the section of Chatham Road North between its junctions with Bulkeley Street and Valley Road, as delineated and shown in yellow on the Plan numbered KTE/G03/0007/1 with details as follows:
 - (a) from 0.00 a.m. to 6.00 a.m. on Sundays only during the period of 2 January to 31 March 2015, with all carriageways and parts of the footpath widths of the section of the road closed; and
 - (b) from 2 January to 25 September 2015, except the periods specified in (III)(a) above, with parts of the carriageway and footpath widths of the section of the road closed,

for the purposes or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the footbridges and the section of the road to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered KTE/G03/0007/1 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the footbridges and the road affected by the Order on 19 December 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge and the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge and the road affected by the Order.

Notice is hereby given that further closure of the same part or parts of the footbridge and the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

| (c) The section of Chatham Road North between its junctions with Bulkeley Street and Valley Road, as delineated and shown in yellow on the Plan. | From 0.00 a.m. to 6.00 a.m. on Sundays only during the period of 2 January to 31 March 2015, all carriageways and parts of the footpath widths will be temporarily closed to facilitate the demolition of the existing footbridge across Chatham Road North. |

Except the periods specified above, parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Kwun Tong Line Extension, and a footbridge and its associated structures.

Statement on Personal Data
