## **Amendments to Scheme under Section 7**

## Amendments

Pursuant to section 7 of the Railways Ordinance (Chapter 519), the Secretary for Transport and Housing proposes to amend the scheme for the Kwun Tong Line Extension, which was referred to in G.N. 7303 published on 27 November and 4 December 2009 as amended by the amendments referred to in G.N. 3671 published on 25 June and 2 July 2010, and was authorized by the Chief Executive in Council under section 11(4) of the Railways Ordinance as notified in G.N. 7669 published on 10 and 17 December 2010.

- 2. The Secretary for Transport and Housing proposes the amendments to the scheme as described below and shown on 'Revision 2' of the General Layout Plan No. KTE-G04; 'Revision 2' of the Land Resumption Plan No. KTE-L02; 'Revision 2' of the Underground Strata Resumption Plan No. KTE-U03; 'Revision 2' of the Creation of Rights of Temporary Occupation of Land Plan No. KTE-T02; 'Revision 2' of the Creation of Easements and/or Other Permanent Rights Plan No. KTE-R01 and 'Revision 2' of the Control of Building Plans and Commencement of Work Plan No. KTE-P01 (the 'Amendment Plans') annexed hereto.
