# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF PART OF SOUTHORN PLAYGROUND

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 2 March 2016 (the 'Order'), authorized the temporary closure of part of Southorn Playground, as delineated and shown in yellow on the Plan numbered LTS/G01/0001/3 during the period from 1 April to 30 December 2016 for the purposes of or incidental to the railway scheme of the MTR Wan Chai Station Lee Tung Street Subway. A description of the works to be carried out, the area of Southorn Playground to be affected and the manner in which it will be affected is given in the Schedule below.

Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Southorn Playground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Southorn Playground affected by the Order.

Notice is hereby given that further closure of the same part or parts of Southorn Playground or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
