**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PARTS OF SOUTHORN PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 3 March 2015 (the ‘Order’), authorized:–

- (I) the temporary closure of part of Southorn Playground during the period from 1 April to 28 June 2015, as delineated and shown in blue on the Plan numbered LTS/G01/0001/2; and
- (II) the temporary closure of part of Southorn Playground during the period from 1 April 2015 to 31 March 2016, as delineated and shown in yellow on the Plan numbered LTS/G01/0001/2,

for the purposes of or incidental to the railway scheme of the MTR Wan Chai Station Lee Tung Street Subway. A description of the works to be carried out, the areas of Southorn Playground to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered LTS/G01/0001/2 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near Southorn Playground affected by the Order on 13 March 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Southorn Playground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Southorn Playground affected by the Order.

Notice is hereby given that further closure of the same part or parts of Southorn Playground or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

Southorn Playground to be affected

Description of the works and the manner in which Southorn Playground will be affected

Parts of Southorn Playground, as delineated and shown in blue and yellow on the Plan numbered LTS/G01/0001/2.

Parts of Southorn Playground will be temporarily closed to facilitate the construction of the MTR Wan Chai Station Lee Tung Street Subway and the associated railway facilities.

Statement on Personal Data
