**AUTHORIZATION FOR
PERMANENT CLOSURE OF PART OF COVERED PEDESTRIAN WALKWAY
CONNECTING TO KAM SHEUNG ROAD STATION; TEMPORARY PARTIAL
CLOSURE AND ALTERATION OF PARTS OF FOOTPATHS AND OPEN PLACE
NEAR KAM SHEUNG ROAD STATION, AND SECTIONS OF TUNG WUI ROAD
CARRIAGEWAYS, FOOTPATHS AND CYCLING TRACK; TEMPORARY
CLOSURE OF BICYCLE PARKING SPACES; AND TEMPORARY CLOSURE
OF PEDESTRIAN SUBWAY AT KAM HO ROAD (HIGHWAYS DEPARTMENT
STRUCTURE NO. NS273)**

In exercise of the powers delegated by the Secretary for Transport and Logistics, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) the permanent closure of part of the covered pedestrian walkway connecting to Kam Sheung Road Station as delineated and shown in orange on the Plan numbered NOL/G02/0001/1 with effect from 18 September 2026; and
- (II)
 - (a) the temporary partial closure and alteration of parts of the footpaths and open place near Kam Sheung Road Station as delineated and shown in green on the Plan numbered NOL/G02/0001/1;
 - (b) the temporary partial closure and alteration of sections of Tung Wui Road carriageways, footpaths and cycling track as delineated and shown in brown on the Plan numbered NOL/G02/0001/1;
 - (c) the temporary closure of bicycle parking spaces as delineated and shown in yellow on the Plan numbered NOL/G02/0001/1; and
 - (d) the temporary closure of pedestrian subway at Kam Ho Road (Highways Department Structure No. NS273) as delineated and shown in blue on the Plan numbered NOL/G02/0001/1,

during the period from 18 September 2026 to 17 September 2027.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over the part of the pedestrian walkway as described in (I) above with effect from 18 September 2026; and the parts of footpaths and open place, sections of carriageways and cycling track, bicycle parking spaces and pedestrian subway as described in (II) above

during the period from 18 September 2026 to 17 September 2027, shall be extinguished, modified or restricted, as the case may be.
