

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF SAI SHA ROAD,
HANG MING STREET AND HANG FAI STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 24 February 2014 (the 'Order'), authorized:-

- (I) the temporary closure of the section of Sai Sha Road northbound between Hang Fai Street and Hang Ming Street, as delineated and shown in pink on the Plan numbered SCL/G44/0035/1:
 - (a) from 2.00 a.m. to 4.00 a.m. during the periods of (i) 24 to 29 March 2014, (ii) 31 March to 4 April 2014, (iii) 7 to 12 April 2014, (iv) 14 to 17 April 2014, (v) 23 to 28 June 2014, (vi) 2 to 5 July 2014, (vii) 7 to 12 July 2014, (viii) 14 to 19 July 2014, (ix) 4 to 9 August 2014, and (x) 11 to 16 August 2014, with all carriageways and parts of the footpath widths of the section of the road closed; and
 - (b) from 21 March 2014 to 20 March 2015, except the periods specified in (I)(a) above, with parts of the carriageway and footpath widths of the section of the road closed, and
- (II) (a) the temporary partial closure of the section of Sai Sha Road between a point about 60 metres southwest of its junction with Hang Fai Street and a point about 20 metres northeast of its junction with Hang Ming Street (except the section of Sai Sha Road specified in (I) above), as delineated and shown in yellow on the Plan numbered SCL/G44/0035/1;
- (b) the temporary partial closure of the section of Hang Ming Street between its junction with Sai Sha Road and a point about 20 metres northwest of the junction, as delineated and shown in red on the Plan numbered SCL/G44/0035/1; and
- (c) the temporary partial closure of the section of Hang Fai Street between its junction with Sai Sha Road northbound and a point about 60 metres northwest of the junction, and the section of Hang Fai Street between its junction with Sai Sha Road southbound and a point about 60 metres southeast of the junction, as delineated and shown in green on the Plan numbered SCL/G44/0035/1,

during the period from 21 March 2014 to 20 March 2015,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G44/0035/1 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the roads affected by the Order on 7 March 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(b) The section of Sai Sha Road between a point about 60 metres southwest of its junction with Hang Fai Street and a point about 20 metres northeast of its junction with Hang Ming Street (except the section of Sai Sha Road specified in (a) above), and the section of Hang Ming Street between its junction with Sai Sha Road and a point about 20 metres northwest of the junction, as delineated and shown in yellow and red respectively on the Plan.	<p>Parts of the carriageway and footpath widths will be temporarily closed to facilitate the modification works of the MTR Heng On Station in relation to the Shatin to Central Link.</p>
(c) The section of Hang Fai Street between its junction with Sai Sha Road northbound and a point about 60 metres northwest of the junction and the section of Hang Fai Street between its junction with Sai Sha Road southbound and a point about 60 metres southeast of the junction, as delineated and shown in green on the Plan.	<p>Parts of the carriageway and footpath widths will be temporarily closed to facilitate the modification works of the MTR Heng On Station in relation to the Shatin to Central Link.</p>
