NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF CONVENTION AVENUE AND FENWICK PIER STREET; AND LUNG KING STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 3 March 2021 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Convention Avenue between its junction with Fenwick Pier Street and a point about 180 metres east of the junction, as delineated and shown in yellow on the Plans numbered SCL/G35/0053/2 and SCL/G36/0053/1;
- (II) the temporary partial closure of the section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in green on the Plan numbered SCL/G36/0053/1; and
- (III) the temporary partial closure of Lung King Street, as delineated and shown in red on the Plan numbered SCL/G36/0053/1,

during the period from 8 April to 31 December 2021 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:-

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) The section of Convention Avenue between its junction with Fenwick Pier Street and a point about 180 metres east of the junction, as delineated and shown in yellow on the Plans numbered SCL/G35/0053/2 and SCL/G36/0053/1. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(b) The section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in green on the Plan numbered SCL/G36/0053/1. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
