

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF LUNG CHEUNG ROAD,
FUNG TAK ROAD AND PO KONG VILLAGE ROAD, AND
A STAIRCASE AND FOOTPATH CONNECTING
CHOI HUNG ROAD AND LUNG CHEUNG ROAD; AND
TEMPORARY ALTERATION OF A SECTION OF LUNG CHEUNG ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 24 March 2017 (the ‘Order’), authorized:–

- (I) (a) the temporary partial closure of the sections of Lung Cheung Road adjacent to Fung Tak Park, as delineated and shown in yellow on the Plan numbered SCL/G09/0015/5;
- (b) the temporary partial closure of the section of Fung Tak Road between a point about 80 metres east of its junction with Po Kong Village Road and a point about 60 metres west of the junction, as delineated and shown in beige on the Plan numbered SCL/G09/0015/5; and
- (c) the temporary partial closure of the section of Po Kong Village Road between a point about 200 metres northeast of its junction with Shung Wah Street and a point about 120 metres south of its junction with Fung Tak Road, as delineated and shown in red on the Plans numbered SCL/G09/0015/5 and SCL/G10/0036/4,

during the period from 19 April to 31 December 2017; and

- (II) (a) the temporary partial closure of the section of Lung Cheung Road between its junction with Tai Hom Road near Lung Poon Court and a point about 30 metres west of its junction with Po Kong Village Road, and the section of Lung Cheung Road between a point about 370 metres southeast of its junction with Tai Hom Road near Lung Poon Court and a point about 830 metres southeast of the junction, as delineated and shown in green on the Plans numbered SCL/G09/0015/5, SCL/G11/0016/5 and SCL/G12/0016/5;
- (b) the temporary partial closure of the staircase and footpath connecting Choi Hung Road and Lung Cheung Road (near Entrance A2 of the MTR Diamond Hill Station), as delineated and shown in dark purple on the Plan numbered SCL/G11/0016/5; and

- (c) the temporary alteration of the section of Lung Cheung Road between its junction with Tai Hom Road near Lung Poon Court and a point about 370 metres southeast of the junction, as delineated and shown in blue on the Plan numbered SCL/G11/0016/5,

during the period from 19 April 2017 to 18 April 2018,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads, the staircase and the footpath to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G09/0015/5, SCL/G10/0036/4, SCL/G11/0016/5 and SCL/G12/0016/5 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of the roads, the staircase and the footpath or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads, the staircase and the footpath affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of the roads, the staircase and the footpath or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.
