

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF THE FOOTBRIDGE ACROSS
HARBOUR ROAD, SECTIONS OF CONVENTION AVENUE AND
FENWICK PIER STREET; AND LUNG KING STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 March 2016 (the 'Order'), authorized:-

- (I) the temporary partial closure of part of the footbridge across Harbour Road connecting the podium near Harbour Centre and the podium near Causeway Centre, as delineated and shown in blue on the Plan numbered SCL/G35/0053/1 during the period from 1 April to 30 September 2016; and
- (II) (a) the temporary partial closure of the section of Convention Avenue between its junction with Fenwick Pier Street and a point about 180 metres east of the junction, as delineated and shown in yellow on the Plans numbered SCL/G35/0053/1 and SCL/G36/0053/1;
(b) the temporary partial closure of the section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in green on the Plan numbered SCL/G36/0053/1; and
(c) the temporary partial closure of Lung King Street, as delineated and shown in red on the Plan numbered SCL/G36/0053/1,

during the period from 8 April 2016 to 7 April 2017,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the part of the footbridge and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G35/0053/1 and SCL/G36/0053/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the footbridge and the roads affected by the Order on 24 March 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the footbridge and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
