# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF A STAIRCASE AND FOOTPATH CONNECTING CHOI HUNG ROAD AND LUNG CHEUNG ROAD; AND SECTIONS OF LUNG CHEUNG ROAD, TAI HOM ROAD, LUNG POON STREET AND SHEUNG YUEN STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 22 March 2013 (the 'Order'), authorized:-

- (I) the temporary partial closure of a staircase and footpath connecting Choi Hung Road and Lung Cheung Road (near Entrance A2 of the MTR Diamond Hill Station), as delineated and shown in dark purple on the Plan numbered SCL/G11/0016/1;
- (II) the temporary partial closure of the section of Lung Cheung Road between a point about 30 metres west of its junction with Po Kong Village Road and a point about 170 metres southeast of its junction with Hammer Hill Road, as delineated and shown in green on the Plans numbered SCL/G09/0016/1, SCL/G11/0016/1 and SCL/G12/0016/1;
- (III) the temporary partial closure of the section of Tai Hom Road between its junctions with Lung Cheung Road near Lung Poon Court and Nan Lian Garden, as delineated and shown in yellow on the Plans numbered SCL/G09/0016/1, SCL/G11/0016/1 and SCL/G12/0016/1;
- (IV) the temporary partial closure of the section of Lung Poon Street between its junction with Tai Hom Road and a point about 90 metres north of the junction, as delineated and shown in orange on the Plans numbered SCL/G09/0016/1 and SCL/G11/0016/1; and
- (V) the temporary partial closure of the section of Sheung Yuen Street between its junction with Tai Hom Road and a point about 50 metres east of the junction, as delineated and shown in brown on the Plan numbered SCL/G11/0016/1,

during the period from 19 April 2013 to 18 April 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the staircase, the footpath and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the staircase, the footpath and the roads affected by the Order on 5 April 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the staircase, the footpath and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the staircase, the footpath and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the staircase, the footpath and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

## SCHEDULE

The staircase, the footpath and the roads to be affected

- (a) A staircase and footpath connecting Choi Hung Road and Lung Cheung Road (near Entrance A2 of the MTR Diamond Hill Station), as delineated and shown in dark purple on the Plan numbered SCL/G11/0016/1.
- (b) The section of Lung Cheung Road between a point about 30 metres west of its junction with Po Kong Village Road and a point about 170 metres southeast of its junction with Hammer Hill Road, as delineated and shown in green on the Plans numbered SCL/G09/0016/1, SCL/G11/0016/1 and SCL/G12/0016/1.
- (c) The section of Tai Hom Road between its junctions with Lung Cheung Road near Lung Poon Court and Nan Lian Garden, as delineated and shown in yellow on the Plans numbered SCL/G09/0016/1, SCL/G11/0016/1 and SCL/G12/0016/1.
- (d) The section of Lung Poon Street between its junction with Tai Hom Road and a point about 90 metres north of the junction, as delineated and shown in orange on the Plans numbered SCL/G09/0016/1 and SCL/G11/0016/1.
- (e) The section of Sheung Yuen Street between its junction with Tai Hom Road and a point about 50 metres east of the junction, as delineated and shown in brown on the Plan numbered SCL/G11/0016/1.

Description of the works and the manner in which the staircase, the footpath and the roads will be affected

Parts of the staircase and footpath widths will be temporarily closed in connection with the construction of railway tunnel at Diamond Hill and the associated railway facilities of the Shatin to Central Link, and the extension of the MTR Diamond Hill Station.

Parts of the carriageway and footpath widths will be temporarily closed in connection with the construction of the railway tunnel at Diamond Hill and the associated railway facilities of the Shatin to Central Link, and the extension of the MTR Diamond Hill Station.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of railway tunnel at Diamond Hill and the associated railway facilities of the Shatin to Central Link.

Parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of Entrance A1 at the MTR Diamond Hill Station and the associated railway facilities of the Shatin to Central Link.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of railway tunnel at Diamond Hill and the associated railway facilities of the Shatin to Central Link.
