**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
RECLAMATION OF AND OTHER WORKS OVER AND UPON  
THE GOVERNMENT FORESHORE AND SEA-BED  
IN THE VICTORIA HARBOUR**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 January 2016 (the 'Order'), authorized the reclamation of and other works over and upon the Government foreshore and sea-bed in the Victoria Harbour, as delineated and shown in yellow and green respectively on the Plans numbered SCL/G31/0051/1 and SCL/G33/0051/1 during the period from 1 February 2016 to 31 December 2020 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of the Government foreshore and seabed to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G31/0051/1 and SCL/G33/0051/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed near the Government foreshore and sea-bed affected by the Order on 15 January 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the date of extinction, modification or restriction of his private right in respect of the Government foreshore and sea-bed affected by the Order.

Notice is hereby given that further works over and upon the same part or parts of the Government foreshore and sea-bed or any of such part or parts may be required upon expiration of the Order. Details of any further order for works will be published if and when such an order is made.
