

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF
RODNEY STREET AND HARCOURT ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 March 2019 (the ‘Order’), authorized:-

- (I) the temporary closure of the section of Rodney Street between its junction with Harcourt Road and a point about 80 metres south of the junction, as delineated and shown in blue on the Plan numbered SCL/G37/0064/4, with details as follow:
- (a) from 1:00 a.m. to 6:00 a.m. during the period of 1 April to 30 June 2019, with all carriageway widths of the section of the road temporarily closed; and
- (b) during the period of 1 April to 30 June 2019, except the period specified in (I)(a) above, with parts of the carriageway widths of the section of the road temporarily closed; and
- (II) the temporary partial closure of the section of Rodney Street, and the section of Harcourt Road between its junction with Rodney Street and a point about 120 metres east of the junction, as delineated and shown in yellow and pink respectively on the Plan numbered SCL/G37/0064/4 during the period from 1 April to 30 June 2019,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G37/0064/4 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 15 March 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

During the period of 1 April to 30 June 2019, except the period specified above, parts of the carriageway widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
