SHATIN TO CENTRAL LINK

AUTHORIZATION FOR TEMPORARY CLOSURE OF SECTIONS OF FUNG TAK ROAD, PO KONG VILLAGE ROAD, SHUNG WAH STREET, LUNG CHEUNG ROAD, TAI HOM ROAD AND LUNG POON STREET; AND A STAIRCASE AND FOOTPATH CONNECTING CHOI HUNG ROAD AND LUNG CHEUNG ROAD

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) the temporary partial closure of the section of Fung Tak Road between a point about 250 metres east of its junction with Po Kong Village Road and a point about 40 metres west of the junction, as delineated and shown in beige on the Plan numbered SCL/G09/0015/2;
- (II) the temporary partial closure of the section of Po Kong Village Road between a point about 200 metres northeast of its junction with Shung Wah Street and a point about 40 metres south of its junction with Fung Tak Road, as delineated and shown in red on the Plans numbered SCL/G09/0015/2 and SCL/G10/0036/1;
- (III) the temporary partial closure of the section of Shung Wah Street between its junction with Po Kong Village Road and a point about 30 metres northwest of the junction, as delineated and shown in pink on the Plans numbered SCL/G09/0015/2 and SCL/G10/0036/1:
- (IV) the temporary partial closure of the section of Lung Cheung Road between a point about 30 metres west of its junction with Po Kong Village Road and a point about 170 metres southeast of its junction with Hammer Hill Road, as delineated and shown in green on the Plans numbered SCL/G09/0016/2, SCL/G11/0016/2 and SCL/G12/0016/2;
- (V) the temporary partial closure of the section of Tai Hom Road between its junctions with Lung Cheung Road near Lung Poon Court and Nan Lian Garden, as delineated and shown in yellow on the Plans numbered SCL/G09/0016/2, SCL/G11/0016/2 and SCL/G12/0016/2;
- (VI) the temporary partial closure of the section of Lung Poon Street between its junction with Tai Hom Road and a point about 90 metres north of the junction, as delineated and shown in orange on the Plans numbered SCL/G09/0016/2 and SCL/G11/0016/2; and

(VII) the temporary partial closure of a staircase and footpath connecting Choi Hung Road and Lung Cheung Road (near Entrance A2 of the MTR Diamond Hill Station), as delineated and shown in dark purple on the Plan numbered SCL/G11/0016/2,

during the period from 19 April 2014 to 18 April 2015. I further declare under section 22(1)(c) that during the period from 19 April 2014 to 18 April 2015, all public or private rights in, upon, under or over the sections of the roads, the staircase and the footpath as described above shall be extinguished, modified or restricted, as the case may be.
