**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF ANHUI STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 March 2019 (the ‘Order’), authorized: –

- (I) the temporary closure of the section of Anhui Street between its junction with Ma Tau Wai Road and a point about 15 metres northwest of the junction, as delineated and shown in blue on the Plan numbered SCL/G24/0066/1; and
- (II) the temporary partial closure of the section of Anhui Street between a point about 15 metres northwest of its junction with Ma Tau Wai Road and its junction with Ko Shan Road, as delineated and shown in light green on the Plan numbered SCL/G24/0066/1,

during the period from 31 March to 30 June 2019 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the road to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G24/0066/1 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the road affected by the Order on 22 March 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road affected by the Order. Claims can be submitted via one of the following means: –

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

<i>The road to be affected</i>	<i>Description of the works and the manner in which the road will be affected</i>
(a) The section of Anhui Street between its junction with Ma Tau Wai Road and a point about 15 metres northwest of the junction, as delineated and shown in blue on the Plan numbered SCL/G24/0066/1.	All carriageway and parts of the footpath widths will be temporarily closed to facilitate the reinstatement works.
(b) The section of Anhui Street between a point about 15 metres northwest of its junction with Ma Tau Wai Road and its junction with Ko Shan Road, as delineated and shown in light green on the Plan numbered SCL/G24/0066/1.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the reinstatement works.
