SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
PERMANENT CLOSURE OF A RAMP OF THE FOOTBRIDGE
ACROSS CONVENTION AVENUE; TEMPORARY CLOSURE OF
PART OF THE FOOTBRIDGE ACROSS CONVENTION AVENUE AND
A SECTION OF HARBOUR ROAD; TEMPORARY ALTERATION OF
SECTIONS OF TONNOCHY ROAD, HUNG HING ROAD, FLEMING ROAD,
EXPO DRIVE EAST AND CONVENTION AVENUE; AND
TEMPORARY CLOSURE AND ALTERATION OF A SECTION OF
CONVENTION AVENUE**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 April 2016 (the 'Order'), authorized:-

- (I) the permanent closure of the ramp of the footbridge across Convention Avenue (inside the former Wan Chai Ferry Public Transport Interchange), as delineated and shown in brown on the Plan numbered SCL/G35/0054/1 with effect from 1 May 2016;
- (II) the temporary partial closure of part of the footbridge across Convention Avenue connecting the former Wan Chai Ferry Pier and the podium near Harbour Centre, as delineated and shown in pink on the Plan numbered SCL/G35/0054/1 during the period from 1 May to 22 July 2016;
- (III) the temporary partial closure of the section of Harbour Road between its junction with Tonnochy Road and a point about 70 metres west of the junction, as delineated and shown in red on the Plan numbered SCL/G35/0054/1 during the period from 1 May 2016 to 30 April 2017;
- (IV) the temporary alteration of the section of Tonnochy Road between its junction with Hung Hing Road and its junction with Harbour Road, the section of Hung Hing Road between its junction with Convention Avenue and a point about 100 metres east of the junction, the section of Fleming Road between its junction with Harbour Road and its junction with Convention Avenue, and the section of Expo Drive East between its junction with Convention Avenue and a point about 40 metres north of the junction, as delineated and shown in orange, yellow, green and blue respectively on the Plan numbered SCL/G35/0054/1 during the period from 1 May 2016 to 30 April 2017;
- (V) the temporary alteration of the section of Convention Avenue between its junction with Fleming Road and Expo Drive East and a point about 150 metres west of the junction, as delineated and shown in purple on the Plan numbered SCL/G35/0054/1 during the period from 1 May 2016 to 30 April 2017; and

- (VI) the temporary closure and alteration of the section of Convention Avenue between its junction with Fleming Road and Expo Drive East and its junction with Hung Hing Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/1, with details as follows:
- (a) from 11:00 p.m. to 6:00 a.m. on 1 or 2 days during the period of 1 May to 15 May 2016, with all carriageways and footpaths widths of the section of the road closed; and
 - (b) during the period from 1 May 2016 to 30 April 2017, except the periods specified in (VI)(a) above, with the carriageways and footpaths of the section of the road altered,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the footbridge ramp, the part of the footbridge and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the footbridge ramp, the footbridge and the roads affected by the Order on 15 April 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of the footbridge ramp, the footbridge and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge ramp, the footbridge and the roads affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of the footbridge and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.

(b) Part of the footbridge across Convention Avenue connecting the former Wan Chai Ferry Pier and the podium near Harbour Centre, as delineated and shown in pink on the Plan numbered SCL/G35/0054/1.	Part of the footbridge deck and ramp will be temporarily closed to facilitate the construction of the temporary footbridge, the railway station and the associated railway facilities of the Shatin to Central Link.
(c) The section of Harbour Road between its junction with Tonnochy Road and a point about 70 metres west of the junction, as delineated and shown in red on the Plan numbered SCL/G35/0054/1.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the temporary footbridge, the railway station and the associated railway facilities of the Shatin to Central Link.
