NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF THE ROAD ADJACENT TO MTR CHE KUNG TEMPLE STATION, CHE KUNG MIU ROAD AND SHA TIN TAU ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 April 2014 (the 'Order'), authorized:-

- (I) the temporary closure of the section of the road adjacent to MTR Che Kung Temple Station between its two junctions with Che Kung Miu Road, as delineated and shown in pink and red on the Plan numbered SCL/G39/0017/2, with details as follows :
 - (a) from 0.00 a.m. to 5.30 a.m. during the periods of (i) 12 to 17 May 2014, (ii) 19 to 24 May 2014, (iii) 26 to 31 May 2014, (iv) 3 to 7 June 2014, (v) 9 to 14 June 2014, (vi) 16 to 21 June 2014, and (vii) 23 to 28 June 2014, with all carriageways and footpaths of the section of the road closed, as delineated and shown in pink on the Plan numbered SCL/G39/0017/2,
 - (b) from 10 May 2014 to 9 May 2015, except the periods specified in (I)(a) above, with parts of the carriageway and footpath widths of the section of the road closed, as delineated and shown in pink on the Plan numbered SCL/G39/0017/2, and
 - (c) from 10 May 2014 to 9 May 2015, with parts of the carriageway and footpath widths of the section of the road closed, as delineated and shown in red on the Plan numbered SCL/G39/0017/2;
- (II) the temporary partial closure of the section of Che Kung Miu Road between a point about 100 metres west of its junction with Sha Tin Tau Road and a point about 40 metres east of the junction, as delineated and shown in purple on the Plan numbered SCL/G39/0017/2, during the period from 10 May 2014 to 9 May 2015; and
- (III) the temporary partial closure of the section of Sha Tin Tau Road between its junction with Che Kung Miu Road and a point about 30 metres south of the junction, as delineated and shown in green on the Plan numbered SCL/G39/0017/2, during the period from 10 May 2014 to 9 May 2015,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The roads to be affected

(a) The section of the road adjacent to MTR Che Kung Temple Station between its two junctions with Che Kung Miu Road, as delineated and shown in pink and red on the Plan.

- (b) The section of Che Kung Miu Road between a point about 100 metres west of its junction with Sha Tin Tau Road and a point about 40 metres east of the junction, as delineated and shown in purple on the Plan.
- (c) The section of Sha Tin Tau Road between its junction with Che Kung Miu Road and a point about 30 metres south of the junction, as delineated and shown in green on the Plan.

Description of the works and the manner in which the roads will be affected

From 0.00 a.m. to 5.30 a.m. during the periods of (i) 12 to 17 May 2014, (ii) 19 to 24 May 2014, (iii) 26 to 31 May 2014, (iv) 3 to 7 June 2014, (v) 9 to 14 June 2014, (vi) 16 to 21 June 2014, and (vii) 23 to 28 June 2014, all carriageways and footpaths of the section of the road, delineated and shown in pink, will be temporarily closed.

Except the periods specified above, parts of the carriageway and footpath widths of the section of the road, delineated and shown in pink, will be temporarily closed.

Parts of the carriageway and footpath widths of the section of the road, delineated and shown in red, will be temporarily closed.

The above closure is to facilitate the modification works of the MTR Che Kung Temple Station in relation to the Shatin to Central Link.
