

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF LOK SHAN ROAD PLAYGROUND,
MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN AND
MA TAU WAI ROAD/TO KWA WAN ROAD AMENITY PLOT, AND
PART OF TO KWA WAN COMPLEX PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 23 March 2018 (the ‘Order’), authorized:–

- (I) the temporary closure of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in red, dark blue and dark green respectively on the Plan numbered SCL/G24/0002/4; and
- (II) the temporary closure of part of To Kwa Wan Complex Playground, as delineated and shown in yellow on the Plan numbered SCL/G24/0002/4,

during the period from 17 April 2018 to 16 April 2019 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot and part of To Kwa Wan Complex Playground to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot and To Kwa Wan Complex Playground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot and To Kwa Wan Complex Playground affected by the Order. Claims can be submitted via one of the following means: –

Details of any further order for closure will be published if and when such an order is made.
