AUTHORIZATION FOR TEMPORARY CLOSURE OF PART OF THE OPEN SPACE AND THE FOOTBRIDGE IN TSZ WAN SHAN ROAD REST GARDEN; SECTIONS OF TSZ WAN SHAN ROAD, WAN WAH STREET, WAI WAH STREET, SHEUNG FUNG STREET, YUK WAH STREET AND PO KONG VILLAGE ROAD; AND PART OF THE OPEN SPACE IN TSZ WAN SHAN ESTATE CENTRAL PLAYGROUND

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) (a) the temporary closure of part of the open space and the footbridge in Tsz Wan Shan Road Rest Garden, as delineated and shown in pink and yellow respectively on the Plan numbered SCL/G10/0009/3;
 - (b) the temporary partial closure of the section of Tsz Wan Shan Road between a point about 60 metres southeast of its junction with Ching Fai Street and a point about 190 metres northwest of the junction, and the section of Tsz Wan Shan Road between its junction with Po Kong Village Road and a point about 130 metres north of the junction, both delineated and shown in orange on the Plan numbered SCL/G10/0009/3; and
 - the temporary partial closure of the section of Wan Wah Street between its junction with Tsz Wan Shan Road and a point about 60 metres south of its junction with Yuk Wah Street, the section of Wai Wah Street between its junction with Wan Wah Street and a point about 30 metres east of the junction, the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, the section of Yuk Wah Street between its junction with Wan Wah Street and a point about 170 metres east of the junction, and the section of Po Kong Village Road between a point about 60 metres west of its junction with Tsz Wan Shan Road and a point about 30 metres east of the junction, as delineated and shown in dark green, red, purple, respectively on the Plan numbered beige and light blue SCL/G10/0009/3,

during the period from 21 January 2015 to 20 January 2016; and

(II) the temporary closure of part of the open space in Tsz Wan Shan Estate Central Playground, as delineated and shown in dark blue on the Plan numbered SCL/G10/0011/3 during the period from 1 March 2015 to 20 January 2016.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the open space, the footbridge and the sections of the roads as described in (I) above during the period from 21 January 2015 to 20 January 2016; and (ii) the open space as described in (II) above during the period from 1 March 2015 to 20 January 2016, shall be extinguished, modified or restricted, as the case may be.
