**AUTHORIZATION FOR
TEMPORARY ALTERATION OF SECTIONS OF CONVENTION AVENUE,
MARSH ROAD, TONNOCHY ROAD, HUNG HING ROAD, FLEMING ROAD,
EXPO DRIVE EAST AND EXPO DRIVE CENTRAL; AND
TEMPORARY CLOSURE OF A SECTION OF HARBOUR ROAD, AND
PART OF WAN CHAI SPORTS GROUND**

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) the temporary alteration of the section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/7 during the period from 1 May to 30 September 2019;

- (II) (a) the temporary alteration of the section of Marsh Road between its junction with Hung Hing Road and a point about 30 metres south of the junction, as delineated and shown in dark blue on the Plan numbered SCL/G34/0054/2;

- (b) the temporary alteration of the section of Tonnochy Road between its junction with Hung Hing Road and its junction with Harbour Road, and the section of Hung Hing Road between its junction with Convention Avenue and a point about 40 metres northeast of its junction with Marsh Road, as delineated and shown in orange and yellow respectively on the Plans numbered SCL/G34/0054/2 and SCL/G35/0054/7;

- (c) the temporary alteration of the section of Fleming Road between its junction with Harbour Road and its junction with Convention Avenue, the section of Expo Drive East between its junction with Convention Avenue and a point about 180 metres north of the junction, the section of Expo Drive Central between its junction with Expo Drive East and a point about 35 metres west of the junction, and the section of Convention Avenue between its junction with Fleming Road and a point about 200 metres west of the junction, as delineated and shown in green, blue, brown and purple respectively on the Plan numbered SCL/G35/0054/7; and

- (d) the temporary partial closure of the section of Harbour Road between its junction with Tonnochy Road and a point about 70 metres west of the junction, as delineated and shown in red on the Plans numbered SCL/G34/0054/2 and SCL/G35/0054/7,

during the period from 1 May 2019 to 30 April 2020; and

(III) the temporary closure of part of Wan Chai Sports Ground, as delineated and shown in pink on the Plans numbered SCL/G34/0054/2 and SCL/G35/0054/7 during the period from 3 June 2019 to 2 June 2020.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the section of the road as described in (I) above during the period from 1 May to 30 September 2019; (ii) the sections of the roads as described in (II) above during the period from 1 May 2019 to 30 April 2020; and (iii) the part of Wan Chai Sports Ground as described in (III) above during the period from 3 June 2019 to 2 June 2020, shall be extinguished, modified or restricted, as the case may be.
