# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF OLYMPIC AVENUE AND SUNG WONG TOI ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 January 2013 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Olympic Avenue between Dakota Drive and Hang Wan Road, as delineated and shown in beige on the Plan numbered SCL/G19/0010/1; and
- (II) the temporary partial closure of the section of Sung Wong Toi Road between Hang Wan Road and a point about 60 metres southeast of its junction with Pak Tai Street; and section of Sung Wong Toi Road between Tam Kung Road and a point about 60 metres southeast of its junction with Pak Tai Street, as delineated and shown in yellow on the Plans numbered SCL/G19/0010/1 and SCL/G22/0010/1,

during the period from 1 February 2013 to 31 January 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out and the parts of the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

### **SCHEDULE**

The roads to be affected

Description of the works and the manner in which the roads will be affected

- (a) The section of Olympic Avenue between Dakota Drive and Hang Wan Road, as delineated and shown in beige on the Plan numbered SCL/G19/0010/1.
- Parts of the carriageway and footpath widths will be temporarily closed in connection with the construction of the railway tunnel, railway station at To Kwa Wan and the associated railway facilities of the Shatin to Central Link.
- (b) The section of Sung Wong Toi Road between Hang Wan Road and a point about 60 metres southeast of its junction with Pak Tai Street, and section of Sung Wong Toi Road between Tam Kung Road and a point about 60 metres southeast of its junction with Pak Tai Street, as delineated and shown in yellow on the Plans numbered SCL/G19/0010/1 and SCL/G22/0010/1

Parts of the carriageway and footpath widths will be temporarily closed in connection with the construction of the railway tunnel, railway station at To Kwa Wan and the associated railway facilities of the Shatin to Central Link.
