# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF THE OPEN SPACES AND FOOTBRIDGES IN TUNNEL APPROACH REST GARDEN; SECTIONS OF SLIP ROADS FROM CROSS HARBOUR TUNNEL TO GLOUCESTER ROAD, FROM GLOUCESTER ROAD TO HUNG HING ROAD, AND FROM GLOUCESTER ROAD TO CANAL ROAD FLYOVER; AND A SECTION OF VICTORIA PARK ROAD AND ITS SLIP ROADS

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 January 2014 (the 'Order'), authorized:-

- (I) the temporary closure of part of the open space in Tunnel Approach Rest Garden, as delineated and shown in yellow on the Plan numbered SCL/G34/0031/1;
- the temporary partial closure of part of the open space in Tunnel Approach Rest Garden, as delineated and shown in pink on the Plan numbered SCL/G34/0031/1;
- (III) the temporary closure of a footbridge staircase, within Tunnel Approach Rest Garden, of the footbridge connecting Wan Shing Street and Gloucester Road, as delineated and shown in purple on the Plan numbered SCL/G34/0031/1;
- (IV) the temporary closure of the footbridge staircase and part of the footbridge connecting Percival Street and Tunnel Approach Rest Garden, as delineated and shown in green on the Plan numbered SCL/G34/0031/1;
- (V) the temporary partial closure of the section of a slip road from Cross Harbour Tunnel to Gloucester Road, as delineated and shown in orange on the Plan numbered SCL/G34/0031/1;
- (VI) the temporary partial closure of the sections of slip roads from Gloucester Road to Hung Hing Road, as delineated and shown in red on the Plan numbered SCL/G34/0031/1;
- (VII) the temporary partial closure of the section of a slip road from Gloucester Road to Canal Road Flyover, as delineated and shown in brown on the Plan numbered SCL/G34/0031/1; and
- (VIII) the temporary partial closure of the section of Victoria Park Road and its slip roads, as delineated and shown in blue on the Plan numbered SCL/G34/0031/1,

during the period from 4 February 2014 to 3 February 2015 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of the open spaces, roads and footbridges to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open spaces, roads and footbridges or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open spaces, roads and footbridges affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open spaces, roads and footbridges or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

The footbridge staircase and part of the footbridge will be temporarily closed in connection with the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.
