### NOTICE OF ORDER AUTHORIZING

PERMANENT CLOSURE OF PARTS OF WAN CHAI FERRY PUBLIC TRANSPORT INTERCHANGE; AND SECTIONS OF CONVENTION AVENUE AND EXPO DRIVE EAST; TEMPORARY CLOSURE OF PARTS OF WAN CHAI SPORTS GROUND AND WAN CHAI FERRY PUBLIC TRANSPORT INTERCHANGE; TEMPORARY CLOSURE OF SECTIONS OF HARBOUR ROAD AND FENWICK PIER STREET; AND LUNG KING STREET; AND TEMPORARY ALTERATION OF SECTIONS OF MARSH ROAD, HUNG HING ROAD, TONNOCHY ROAD, FLEMING ROAD, EXPO DRIVE EAST, EXPO DRIVE CENTRAL AND CONVENTION AVENUE

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 June 2022 (the 'Order'), authorized:—

- (I) (a) the permanent closure of parts of Wan Chai Ferry Public Transport Interchange, as delineated and shown in khaki on the Plan numbered SCL/G35/0071/1;
  - (b) the permanent closure of part of the carriageway widths of the section of Convention Avenue between a point about 6 metres east of its junction with Fleming Road and a point about 39 metres east of the junction, and part of the carriageway widths of the section of Convention Avenue between a point about 46 metres east of its junction with Fleming Road and a point about 59 metres east of the junction, as delineated and shown in light green on the Plan numbered SCL/G35/0071/1; and
  - (c) the permanent closure of part of the footpath widths of the section of Expo Drive East between its junction with Convention Avenue and a point about 15 metres north of the junction, as delineated and shown in dark red on the Plan numbered SCL/G35/0071/1.

with effect from 1 July 2022;

- (II) (a) the temporary closure of part of Wan Chai Sports Ground, as delineated and shown in pink on the Plans numbered SCL/G34/0071/1 and SCL/G35/0071/1;
  - (b) the temporary partial closure of part of Wan Chai Ferry Public Transport Interchange, as delineated and shown in green on the Plan numbered

# SCL/G35/0071/1;

- (c) the temporary partial closure of the section of Harbour Road between its junction with Tonnochy Road and a point about 70 metres west of the junction, as delineated and shown in red on the Plans numbered SCL/G34/0071/1 and SCL/G35/0071/1;
- (d) the temporary partial closure of the section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in dark purple on the Plan numbered SCL/G36/0071/1; and
- (e) the temporary partial closure of Lung King Street, as delineated and shown in dark grey on the Plan numbered SCL/G36/0071/1,

during the period from 1 July to 31 December 2022; and

- (III) (a) the temporary alteration of the section of Marsh Road between its junction with Hung Hing Road and a point about 30 metres south of the junction, as delineated and shown in dark blue on the Plan numbered SCL/G34/0071/1;
  - (b) the temporary alteration of the section of Hung Hing Road between its junction with Convention Avenue and a point about 330 metres northeast of the junction, and the section of Tonnochy Road between its junction with Hung Hing Road and its junction with Harbour Road, as delineated and shown in yellow and orange respectively on the Plans numbered SCL/G34/0071/1 and SCL/G35/0071/1;
  - (c) the temporary alteration of the section of Fleming Road between its junction with Harbour Road and its junction with Convention Avenue, the section of Expo Drive East between its junction with Convention Avenue and a point about 180 metres north of the junction, and the section of Expo Drive Central between its junction with Expo Drive East and a point about 35 metres west of the junction, as delineated and shown in purple, blue and grey respectively on the Plan numbered SCL/G35/0071/1; and
  - (d) the temporary alteration of the section of Convention Avenue, as delineated and shown in beige on the Plans numbered SCL/G35/0071/1 and SCL/G36/0071/1,

during the period from 1 July to 31 December 2022,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, Wan Chai Ferry Public Transport Interchange, the area of part of Wan Chai Sports Ground and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure/alteration of the relevant part or parts of Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads affected by the Order. Claims can be submitted via one of the following means:—

Notice is hereby given that further closure/alteration of the same part or parts of Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads or any of

such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.

Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads to be affected Description of the works and the manner in which Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads will be affected

- (a) Parts of Wan Chai Ferry Public Transport Interchange, as delineated and shown in khaki on the Plan numbered SCL/G35/0071/1.
- Parts of Wan Chai Ferry Public Transport Interchange will be permanently closed for the provision of the railway station entrance and the associated facilities of the Shatin to Central Link.
- (b) Part of the carriageway widths of the section of Convention Avenue between a point about 6 metres east of its junction with Fleming Road and a point about 39 metres east of the junction, and part of the carriageway widths of the section of Convention Avenue between a point about 46 metres east of its junction with Fleming Road and a point about 59 metres east of the junction, as delineated and shown in light green on the Plan numbered SCI./G35/0071/1.

Parts of the carriageway width will be permanently closed for the provision of the associated facilities of the Shatin to Central Link

(c) Part of the footpath widths of the section of Expo Drive East between its junction with Convention Avenue and a point about 15 metres north of the junction, as delineated and shown in dark red on the Plan numbered SCL/G35/0071/1. Part of the footpath width will be permanently closed for the provision of the associated facilities of the Shatin to Central Link

(d) Part of Wan Chai Sports Ground, as delineated and shown in pink on the Plans numbered SCL/G34/0071/1 and SCL/G35/0071/1. Part of Wan Chai Sports Ground will be temporarily closed to facilitate the reinstatement works.

- (e) Part of Wan Chai Ferry Public Transport Interchange, as delineated and shown in green on the Plan numbered SCL/G35/0071/1.
- Parts of Wan Chai Ferry Public Transport Interchange will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
- (f) The section of Harbour Road between its junction with Tonnochy Road and a point about 70 metres west of the junction, as delineated and shown in red on the Plans numbered SCL/G34/0071/1 and SCL/G35/0071/1.
- Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link.
- (g) The section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in dark purple on the Plan numbered SCL/G36/0071/1.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(h) Lung King Street, as delineated and shown in dark grey on the Plan numbered SCL/G36/0071/1. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(i) The section of Marsh Road between its junction with Hung Hing Road and a point about 30 metres south of the junction, as delineated and shown in dark blue on the Plan numbered SCL/G34/0071/1. The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the reinstatement works. Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads to be affected Description of the works and the manner in which Wan Chai Ferry Public Transport Interchange, Wan Chai Sports Ground and the roads will be affected

(j) The section of Hung Hing Road between its junction with Convention Avenue and a point about 330 metres northeast of the junction, and the section of Tonnochy Road between its junction with Hung Hing Road and its junction with Harbour Road, as delineated and shown in yellow and orange respectively on the Plans numbered SCL/G34/0071/1 and SCL/G35/0071/1. The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the associated railway facilities of the Shatin to Central Link

(k) The section of Fleming Road between its junction with Harbour Road and its junction with Convention Avenue, and the section of Expo Drive East between its junction with Convention Avenue and a point about 180 metres north of the junction, as delineated and shown in purple and blue respectively on the Plan numbered SCL/G35/0071/1. The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the associated railway facilities of the Shatin to Central Link.

(1) The section of Expo Drive Central between its junction with Expo Drive East and a point about 35 metres west of the junction, as delineated and shown in grey on the Plan numbered SCL/G35/0071/1.

The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the associated railway facilities of the Shatin to Central Link.

(m) The section of Convention Avenue, as delineated and shown in beige on the Plans numbered SCL/G35/0071/1 and SCL/G36/0071/1. The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the associated railway facilities of the Shatin to Central Link.

## Personal Information Collection Statement
