Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 19 April 2018 (the 'Order'), authorized:-

- (I) the permanent closure of part of the carriageway and footpath widths of the section of the road connecting ex-New Territories South Animal Management Center and Che Kung Miu Road, as delineated and shown in purple on the Plan numbered SCL/G03/0037/4 with effect from 16 May 2018;
- (II) the permanent closure of part of Hin Tin Playground, as delineated and shown in blue on the Plan numbered SCL/G03/0037/4 with effect from 15 July 2018; and
- (III) the temporary partial closure of the section of Che Kung Miu Road between a point about 215 metres northeast of its junction with Hin Keng Street and a point about 60 metres southwest of the junction, the section of Hin Keng Street between its junction with Che Kung Miu Road and a point about 60 metres southeast of the junction, and the section of the road connecting ex-New Territories South Animal Management Center and Che Kung Miu Road, as delineated and shown in red, yellow and beige respectively on the Plan numbered SCL/G03/0037/4 during the period from 16 May to 15 August 2018.

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads and the area of part of Hin Tin Playground to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads and Hin Tin Playground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads and Hin Tin Playground affected by the Order. Claims can be submitted via one of the following means:—

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The roads and Hin Tin Playground to be affected

Description of the works and the manner in which the roads and Hin Tin Playground will be affected

(a) Part of the carriageway and footpath widths of the section of the road connecting ex-New Territories South Animal Management Center and Che Kung Miu Road, as delineated and shown in purple on the Plan numbered SCI/G03/0037/4. Part of the carriageway and footpath widths will be permanently closed for the provision of the railway station and the associated railway facilities of the Shatin to Central Link.

(b) Part of Hin Tin Playground, as delineated and shown in blue on the Plan numbered SCL/G03/0037/4. Part of Hin Tin Playground will be permanently closed for the provision of the railway station and the associated railway facilities of the Shatin to Central Link.

(c) The section of Che Kung Miu Road between a point about 215 metres northeast of its junction with Hin Keng Street and a point about 60 metres southwest of the junction, and the section of the road connecting ex-New Territories South Animal Management Center and Che Kung Miu Road, as delineated and shown in red and beige respectively on the Plan numbered SCL/G03/0037/4. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station and the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(d) The section of Hin Keng Street between its junction with Che Kung Miu Road and a point about 60 metres southeast of the junction, as delineated and shown in yellow on the Plan numbered SCI/G03/0037/4. Parts of the footpath widths will be temporarily closed to facilitate the construction of the railway station and the associated railway facilities of the Shatin to Central Link, and reinstatement works.
