

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
PART OF THE OPEN SPACE AND THE FOOTBRIDGE
IN TSZ WAN SHAN ROAD REST GARDEN; AND
SECTIONS OF TSZ WAN SHAN ROAD, WAN WAH STREET,
WAI WAH STREET, SHEUNG FUNG STREET,
YUK WAH STREET AND PO KONG VILLAGE ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 18 December 2012 (the 'Order'), authorized:-

- (I) the temporary closure of part of the open space and the footbridge in Tsz Wan Shan Road Rest Garden, as delineated and shown in pink and yellow respectively on the Plan numbered SCL/G10/0009/1;
- (II) the temporary partial closure of the section of Tsz Wan Shan Road between its junction with Ching Fai Street and a point about 190 metres northwest of the junction and the section of Tsz Wan Shan Road between its junction with Po Kong Village Road and a point about 130 metres north of the junction, both delineated and shown in orange on the Plan numbered SCL/G10/0009/1;
- (III) the temporary partial closure of the section of Wan Wah Street between its junction with Tsz Wan Shan Road and a point about 60 metres south of its junction with Yuk Wah Street, as delineated and shown in dark green on the Plan numbered SCL/G10/0009/1;
- (IV) the temporary partial closure of the section of Wai Wah Street between its junction with Wan Wah Street and a point about 30 metres east of the junction, as delineated and shown in red on the Plan numbered SCL/G10/0009/1;
- (V) the temporary partial closure of the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, as delineated and shown in purple on the Plan numbered SCL/G10/0009/1;
- (VI) the temporary partial closure of the section of Yuk Wah Street between its junction with Wan Wah Street and a point about 170 metres east of the junction, as delineated and shown in beige on the Plan numbered SCL/G10/0009/1; and

- (VII) the temporary partial closure of the section of Po Kong Village Road between a point about 60 metres west of its junction with Tsz Wan Shan Road and a point about 30 metres east of the junction, as delineated and shown in light blue on the Plan numbered SCL/G10/0009/1;

during the period from 21 January 2013 to 20 January 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the open space, the footbridge and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G10/0009/1 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the open space, the footbridge and the roads affected by the Order on 4 January 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd

Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open space, the footbridge and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space, the footbridge and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open space, the footbridge and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
