**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF  
PARTS OF TUNNEL APPROACH REST GARDEN;  
PARTS OF THE FOOTBRIDGES IN TUNNEL APPROACH REST GARDEN;  
SECTIONS OF SLIP ROADS FROM GLOUCESTER ROAD TO  
CROSS HARBOUR TUNNEL, FROM GLOUCESTER ROAD TO  
CANAL ROAD FLYOVER, AND FROM CROSS HARBOUR TUNNEL TO  
VICTORIA PARK ROAD, AND A SECTION OF VICTORIA PARK ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 January 2016 (the 'Order'), authorized:-

- (I) the temporary closure of part of Tunnel Approach Rest Garden (near Canal Road Flyover), as delineated and shown in yellow on the Plan numbered SCL/G34/0031/3;
- (II) the temporary partial closure of part of Tunnel Approach Rest Garden (near Victoria Park Road), as delineated and shown in pink on the Plan numbered SCL/G34/0031/3;
- (III) the temporary closure of part of the footbridge connecting Wan Shing Street and Gloucester Road, and part of the footbridge connecting Percival Street and Tunnel Approach Rest Garden, as delineated and shown in purple and green respectively on the Plan numbered SCL/G34/0031/3;
- (IV) the temporary partial closure of sections of the slip roads from Gloucester Road to Cross Harbour Tunnel, from Gloucester Road to Canal Road Flyover, and from Cross Harbour Tunnel to Victoria Park Road, as delineated and shown in red, brown and beige respectively on the Plan numbered SCL/G34/0031/3; and
- (V) the temporary partial closure of the section of Victoria Park Road between its junction with its slip roads and a point about 140 metres northeast of the junction, as delineated and shown in blue on the Plan numbered SCL/G34/0031/3,

during the period from 4 February 2016 to 3 February 2017 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of Tunnel Approach Rest Garden, the parts of the footbridges and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near Tunnel Approach Rest Garden, the footbridges and the roads affected by the Order on 22 January 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Tunnel Approach Rest Garden, the footbridges and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Tunnel Approach Rest Garden, the footbridges and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of Tunnel Approach Rest Garden, the footbridges and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
