NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF PART OF HONG KONG PARK, AND A SECTION OF SUPREME COURT ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 June 2019 (the 'Order'), authorized:-

- (I) the temporary closure of part of Hong Kong Park, as delineated and shown in purple on the Plan numbered SCL/G37/0056/1; and
- (II) the temporary partial closure of the section of Supreme Court Road between its junction with Justice Drive and a point about 180 metres northwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G37/0056/1,

during the period from 5 July 2019 to 4 July 2020 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of part of Hong Kong Park and the section of the road to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of Hong Kong Park and the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Hong Kong Park and the road affected by the Order. Claims can be submitted via one of the following means:-

Notice is hereby given that further closure of the same part or parts of Hong Kong Park and the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

Hong Kong Park and the road to be affected

Description of the works and the manner in which Hong Kong Park and the road will be affected

(a) Part of Hong Kong Park, as delineated and shown in purple on the Plan numbered SCL/G37/0056/1. Part of Hong Kong Park will be temporarily closed to facilitate the construction of the railway tunnels, the ventilation and plant building and the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(b) The section of Supreme Court Road between its junction with Justice Drive and a point about 180 metres northwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G37/0056/1. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnels, ventilation shaft and the associated railway facilities of the Shatin to Central Link, and reinstatement works.

Personal Information Collection Statement
