

RAILWAYS ORDINANCE (Chapter 519)
(Order under section 22(1))

SHATIN TO CENTRAL LINK

**AUTHORIZATION FOR
TEMPORARY CLOSURE OF SECTIONS OF
NAM KOK ROAD, PRINCE EDWARD ROAD WEST,
OLYMPIC AVENUE AND SUNG WONG TOI ROAD**

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:-

- (I) the temporary partial closure of part of the carriageway widths of the section of Nam Kok Road between a point about 40 metres south of its junction with Nga Tsin Wai Road and a point about 80 metres south of the junction, as delineated and shown in green on the Plans numbered SCL/G18/0013/6 and SCL/G19/0010/5 during the period from 1 February to 30 June 2018;
- (II) the temporary partial closure of part of the carriageway widths of the section of Nam Kok Road between a point about 30 metres south of its junction with Nga Tsin Wai Road and a point about 100 metres south of the junction, as delineated and shown in orange on the Plans numbered SCL/G18/0013/6 and SCL/G19/0010/5 during the period from 1 February to 31 August 2018;
- (III) (a) the temporary partial closure of the section of Nam Kok Road between Nga Tsin Wai Road and Prince Edward Road West, as delineated and shown in red on the Plans numbered SCL/G18/0013/6 and SCL/G19/0010/5; and

(b) the temporary partial closure of the section of Prince Edward Road West between a point about 5 metres east of its junction with Nam Kok Road and a point about 20 metres west of the junction, as delineated and shown in pink on the Plans numbered SCL/G18/0013/6 and SCL/G19/0010/5,

during the period from 1 February to 31 October 2018;
- (IV) the temporary partial closure of the section of Olympic Avenue between its junction with Dakota Drive and a point about 80 metres southwest of the junction, as delineated and shown in blue on the Plan numbered SCL/G19/0010/5 during the period from 1 February to 30 September 2018; and
- (V) the temporary partial closure of the section of Olympic Avenue between a point about 80 metres southwest of its junction with Dakota Drive and its junction with Hang Wan Road, and the section of Sung Wong Toi Road between its junction with Hang Wan Road and a point about 100 metres south of the junction, as delineated and shown in beige and yellow respectively on the Plan

numbered SCL/G19/0010/5 during the period from 1 February 2018 to 31 January 2019.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the section of the road as described in (I) above during the period from 1 February to 30 June 2018; (ii) the section of the road as described in (II) above during the period from 1 February to 31 August 2018; (iii) the sections of the roads as described in (III) above during the period from 1 February to 31 October 2018; (iv) the section of the road as described in (IV) above during the period from 1 February to 30 September 2018; and (v) the sections of the roads as described in (V) above during the period from 1 February 2018 to 31 January 2019, shall be extinguished, modified or restricted, as the case may be.
