

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY ALTERATION OF SECTIONS OF EXPO DRIVE EAST,
EXPO DRIVE CENTRAL AND CONVENTION AVENUE**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 July 2016 (the 'Order'), authorized:—

- (I) the temporary alteration of the section of Expo Drive East between a point about 40 metres north of its junction with Convention Avenue and a point about 180 metres north of the junction, as delineated and shown in red on the Plan numbered SCL/G35/0060/1;
- (II) the temporary alteration of the section of Expo Drive Central between its junction with Expo Drive East and a point about 35 metres west of the junction, as delineated and shown in yellow on the Plan numbered SCL/G35/0060/1; and
- (III) the temporary alteration of the section of Convention Avenue between a point about 150 metres west of its junction with Expo Drive East and a point about 200 metres west of the junction, as delineated and shown in orange on the Plan numbered SCL/G35/0060/1,

during the period from 13 August 2016 to 30 April 2017 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G35/0060/1 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public: —

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the alteration of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further alteration of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for alteration will be published if and when such an order is made.
