SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
THE WORKS OVER AND UPON
THE GOVERNMENT FORESHORE AND SEA-BED AT KOWLOON BAY OFF
THE FORMER KAI TAK AIRPORT RUNWAY; AND
TEMPORARY CLOSURE OF THE OPEN SPACES IN LOK SHAN ROAD
PLAYGROUND, MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN,
MA TAU WAI ROAD/TO KWA WAN ROAD AMENITY PLOT, AND
PART OF THE OPEN SPACE IN TO KWA WAN COMPLEX PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 18 July 2013 (the 'Order'), authorized:-

- (I) the works over and upon the Government foreshore and sea-bed at Kowloon Bay off the former Kai Tak Airport runway, as delineated and shown in red on the Plan numbered SCL/G17/0001/1;
- (II) the temporary closure of the open spaces in Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in red, dark blue and dark green respectively on the Plan numbered SCL/G24/0002/2; and
- (III) the temporary closure of part of the open space in To Kwa Wan Complex Playground, as delineated and shown in yellow on the Plan numbered SCL/G24/0002/2,

during the period from 13 August 2013 to 12 August 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out and the areas of the foreshore and sea-bed and the open spaces to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22/F, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the date of extinction, modification or restriction of his private right in respect of the relevant part or parts of the the Government foreshore and sea-bed and open spaces affected by the Order.

Notice is hereby given that further works over and upon the same part or parts of the Government foreshore and sea-bed and further closure of the same part or parts of the open spaces or any of such part or parts may be required upon expiration of the Order. Details of any further order for works and closure will be published if and when such an order is made.
