A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

Description of the works and the manner in which the road will be affected

The section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/4. The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the railway station and the associated railway facilities of the Shatin to Central Link.
