SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
THE WORKS OVER AND UPON THE GOVERNMENT FORESHORE
AND SEA-BED IN THE VICTORIA HARBOUR**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 26 June 2015 (the ‘Order’), authorized the works over and upon the Government foreshore and sea-bed in the Victoria Harbour, as delineated and shown in blue on the Plan numbered SCL/G30/0040/2 during the period from 18 July to 31 October 2015 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of the Government foreshore and sea-bed to be affected and the manner in which it will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the date of extinction, modification or restriction of his private right in respect of the Government foreshore and sea-bed affected by the Order.

Notice is hereby given that further works over and upon the same part or parts of the Government foreshore and sea-bed or any of such part or parts may be required upon expiration of the Order. Details of any further order for works will be published if and when such an order is made.
