NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF A SECTION OF MA CHAI HANG ROAD, AND PART OF MA CHAI HANG RECREATION GROUND

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 25 August 2020 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Ma Chai Hang Road between a point about 10 metres south of its junction with Chuk Yuen Road and a point about 160 metres southeast of the junction, as delineated and shown in yellow on the Plan numbered SCL/G07/0012/7; and
- (II) the temporary closure of part of Ma Chai Hang Recreation Ground, as delineated and shown in green on the Plan numbered SCL/G07/0012/7,

during the period from 1 October 2020 to 30 September 2021 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road and the area of Ma Chai Hang Recreation Ground to be affected and the manner in which they will be affected is given in the Schedule below.
