A description of the works to be carried out, the areas of the Government foreshore and sea-bed to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the date of extinction, modification or restriction of his private right in respect of the Government foreshore and sea-bed affected by the Order.

Notice is hereby given that further works over and upon the same part or parts of the Government foreshore and sea-bed or any of such part or parts may be required upon expiration of the Order. Details of any further order for works will be published if and when such an order is made.

Description of the works and the manner in which the Government foreshore and sea-bed will be affected

(a) An area of Victoria Harbour, as delineated and shown in yellow on the Plan numbered SCL/G31/0046/1. Temporary reclamation, dredging works, demolition and reprovision of part of the breakwater, and construction of the railway tunnel of the Shatin to Central Link over and upon the Government foreshore and sea-bed

(b) An area of Victoria Harbour, as delineated and shown in green on the Plan numbered SCL/G31/0046/1. Dredging works, demolition and reprovision of part of the breakwater, and construction of the railway tunnel of the Shatin to Central Link over and upon the Government foreshore and sea-bed.

Statement on Personal Data
