

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF
SUNG WONG TOI ROAD, TAM KUNG ROAD AND PAK TAI STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 28 August 2019 (the 'Order'), authorized:-

- (I) (a) the temporary partial closure of the section of Sung Wong Toi Road between a point about 140 metres southeast of its junction with Pak Tai Street and its junction with Tam Kung Road, as delineated and shown in green on the Plans numbered SCL/G19/0065/1 and SCL/G22/0065/2; and
- (b) the temporary partial closure of the section of Tam Kung Road between its junction with Sung Wong Toi Road and a point about 35 metres southwest of the junction, as delineated and shown in purple on the Plan numbered SCL/G22/0065/2,

during the period from 20 September to 31 December 2019;

- (II) the temporary partial closure of sections of Sung Wong Toi Road between its junction with Ma Tau Chung Road and a point about 80 metres southeast of the junction, as delineated and shown in yellow on the Plans numbered SCL/G19/0065/1 and SCL/G22/0065/2 during the period from 1 October to 31 December 2019; and
- (III) the temporary partial closure of the section of Pak Tai Street between its junction with Sung Wong Toi Road and a point about 70 metres southwest of the junction, as delineated and shown in dark blue on the Plans numbered SCL/G19/0065/1 and SCL/G22/0065/2 during the period from 1 October 2019 to 30 June 2020,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0065/1 and SCL/G22/0065/2 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 13 September 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
