NOTICE OF ORDER AUTHORIZING TEMPORARY ALTERATION OF A SECTION OF CHEONG WAN ROAD AND TEMPORARY CLOSURE OF A SECTION OF ON WAN ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 October 2014 (the 'Order'), authorized:-

- (I) the temporary alteration of the section of Cheong Wan Road between its junction with On Wan Road and a point about 180 metres northeast of the junction, as delineated and shown in pink on the Plan numbered SCL/G27/0032/2; and
- (II) the temporary partial closure of the section of On Wan Road between its junction with Cheong Wan Road and a point about 60 metres west of the junction, as delineated and shown in yellow on the Plan numbered SCL/G27/0032/2,

during the period from 24 October 2014 to 2 May 2015 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the alteration/closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further alteration/closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for alteration/closure will be published if and when such an order is made.

SCHEDULE

The roads to be affected

Description of the works and the manner in which the roads will be affected

(a) The section of Cheong Wan Road between its junction with On Wan Road and a point about 180 metres northeast of the junction, as delineated and shown in pink on the Plan. The carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link. The roads to be affected

Description of the works and the manner in which the roads will be affected

(b) The section of On Wan Road between its junction with Cheong Wan Road and a point about 60 metres west of the junction, as delineated and shown in yellow on the Plan. Parts of the carriageway and footpath widths will be temporarily closed for shifting of the junction of Cheong Wan Road and On Wan Road to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.

Statement on Personal Data
