

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE AND ALTERATION OF
A SECTION OF CONVENTION AVENUE; AND
TEMPORARY ALTERATION OF A SECTION OF CONVENTION AVENUE**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 August 2018 (the 'Order'), authorized:-

- (I) the temporary closure and alteration of the section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in red on the Plan numbered SCL/G35/0054/5, with details as follows:
 - (a) from 11:00 p.m. to 6:00 a.m. of the following day on 4 Saturdays or the eve of public holidays during the period from 6 October to 29 December 2018, with all carriageway and parts of the footpath widths of the section of the road temporarily closed; and
 - (b) during the period from 1 October to 31 December 2018, except the period specified in (I)(a) above, with the carriageway and footpath of the section of the road temporarily altered; and
- (II) the temporary alteration of the section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/5 during the period from 1 October to 31 December 2018,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the road to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G35/0054/5 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the road affected by the Order on 31 August 2018.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure/alteration of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road affected by the Order. Claims can be submitted via one of the following means: –

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure/alteration of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.

<p>(b) The section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/5.</p>	<p>The carriageway and footpath will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the railway station and the associated railway facilities of the Shatin to Central Link.</p>
