

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF CHEONG TUNG ROAD,
CHEONG TUNG ROAD SOUTH AND HUNG LING STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 7 November 2014 (the 'Order'), authorized the temporary closure of the section of Cheong Tung Road (and its two adjacent footpaths) between a point about 50 metres northeast of its junction with On Ching Road and its junctions with Cheong Tung Road South and Hung Ling Street, the section of Cheong Tung Road South between its junction with Cheong Tung Road and a point about 40 metres southeast of the junction, the section of Hung Ling Street between its junction with Cheong Tung Road and a point about 20 metres northeast of the junction and the section of Hung Ling Street between its junction with Cheong Tung Road South and a point about 20 metres northwest of the junction, as delineated and shown in red, blue and green respectively on the Plan numbered SCL/G27/0028/2, with details as follows:

- (I) from 1.00 a.m. to 5.30 a.m. during the periods of (i)2 to 3 January 2015, (ii)5 to 10 January 2015, (iii)12 to 17 January 2015, (iv)19 to 24 January 2015, (v)26 to 31 January 2015, (vi)2 to 7 February 2015, (vii) 9 to 14 February 2015 and (viii)23 to 28 February 2015, with all carriageways and parts of the footpath widths of the sections of the roads closed; and
- (II) from 2 December 2014 to 1 December 2015, except the periods specified in (I) above, with parts of the carriageway and footpath widths of the sections of the roads closed,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the roads affected by the Order on 14 November 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

<i>The roads to be affected</i>	<i>Description of the works and the manner in which the roads will be affected</i>
(a) The section of Cheong Tung Road (and its two adjacent footpaths) between a point about 50 metres northeast of its junction with On Ching Road and its junctions with Cheong Tung Road South and Hung Ling Street, as delineated and shown in red on the Plan.	From 1.00 a.m. to 5.30 a.m. during the periods of (i)2 to 3 January 2015, (ii)5 to 10 January 2015, (iii)12 to 17 January 2015, (iv)19 to 24 January 2015, (v)26 to 31 January 2015, (vi)2 to 7 February 2015, (vii)9 to 14 February 2015 and (viii)23 to 28 February 2015, all carriageways and parts of the footpath widths of the sections of the roads, as described in (a), (b) and (c), will be temporarily closed to facilitate the modification works of the MTR Hung Hom Station and the construction of the associated railway facilities in relation to the Shatin to Central Link.
(b) The section of Cheong Tung Road South between its junction with Cheong Tung Road and a point about 40 metres southeast of the junction, as delineated and shown in blue on the Plan.	
(c) The section of Hung Ling Street between its junction with Cheong Tung Road and a point about 20 metres northeast of the junction and the section of Hung Ling Street between its junction with Cheong Tung Road South and a point about 20 metres northwest of the junction, as delineated and shown in green on the Plan.	Except the periods specified above, parts of the carriageway and footpath widths of the sections of the roads, as described in (a), (b) and (c), will be temporarily closed to facilitate the modification works of the MTR Hung Hom Station and the construction of the associated railway facilities of the Shatin to Central Link.
