**NOTICE OF ORDER AUTHORIZING  
 TEMPORARY CLOSURE OF  
 A SECTION OF AN UNNAMED ROAD BETWEEN HIN YAU HOUSE AND  
 HIN FU HOUSE OF HIN KENG ESTATE, SHATIN**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 November 2013 (the 'Order'), authorized the temporary partial closure of a section of the unnamed road between Hin Yau House and Hin Fu House of Hin Keng Estate, Shatin as delineated and shown in yellow on the Plan numbered SCL/G04/0029/1, during the period from 29 November 2013 to 28 November 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G04/0029/1 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the road affected by the Order on 15 November 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road affected by the Order.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

A section of the unnamed road between Hin Yau House and Hin Fu House of Hin Keng Estate, Shatin, as delineated and shown in yellow on the Plan.

Parts of the carriageway and footpath widths will be temporarily closed in connection with the construction of railway tunnel near Hin Keng Estate and the associated railway facilities of the Shatin to Central Link.
