

**RAILWAYS ORDINANCE (Chapter 519)**  
**(Notice under section 23)**

**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE AND ALTERATION OF  
A SECTION OF CONVENTION AVENUE**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 31 October 2019 (the ‘Order’), authorized the temporary closure and alteration of the section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/9, with details as follows:

- (a) from 11:00 p.m. to 6:00 a.m. of the following day on 1 to 4 Saturdays or the eve of public holidays during the period from 1 December 2019 to 30 June 2020, with all carriageway and parts of the footpath widths of the section of the road temporarily closed; and
- (b) during the period from 1 December 2019 to 30 June 2020, except the period specified in (a) above, with the carriageways and footpaths of the section of the road temporarily altered,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G35/0054/9 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the road affected by the Order on 15 November 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure/alteration of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road affected by the Order. Claims can be submitted via one of the following means:—

Notice is hereby given that further closure/alteration of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.

## SCHEDULE

### *Description of the works and the manner in which the road will be affected*

The section of Convention Avenue between its junction with Tonnochy Road and its junction with Fleming Road, as delineated and shown in beige on the Plan numbered SCL/G35/0054/9.

From 11:00 p.m. to 6:00 a.m. of the following day on 1 to 4 Saturdays or the eve of public holidays during the period from 1 December 2019 to 30 June 2020, all carriageway and parts of the footpath widths will be temporarily closed to facilitate the construction of the permanent footbridge and the demolition of the temporary footbridge.

*The road to be affected*

*Description of the works and the manner in which the road will be affected*

During the period from 1 December 2019 to 30 June 2020, except the period specified above, the carriageways and footpaths will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the permanent footbridge, the demolition of the temporary footbridge, and the construction of the railway station and the associated railway facilities of the Shatin to Central Link.

### **Personal Information Collection Statement**

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims served under section 34 of the Railways Ordinance (Chapter 519) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 34 of the Railways Ordinance is obligatory. If such information, including the personal data, as required under section 34 of the Railways Ordinance is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
